PERSHING (SOUTH PEAK)

For those not already familiar with the geography of this area, Mt. Pershing is located on the eastern side of the Olympics, in the southeastern area of the park, just to the west of Mt. Blinor and Mt. Washington.

I had been within 40 feet of the summit two years ago and have been wanting to go back ever since. When Susan and I went up Mt. Washington to get a view of the route on Pershing, we ran into Arnie Bloomer and his daughter. I asked Arnie if he had been up Pershing and he said yes. It was not until later, when I looked at the Climber's Guide to the Olympic Mountains that I realized that he had made the very first ascent up Route 1 in 1966.

Three days later the weather cleared so I took off early and headed up Jefferson Creek. I wanted to do Route 7, but by the time I got through the woods to a clearing where I could see anything, I found that I had gotten all the way over to Route 1. I wondered if I had been meant to do this route after running into Arnie. I made my way up to the south end of the ridge and then had to go back and forth from east to west and along the ridge crest until I finally reached the summit. I was glad to have finally gotten there and find the register. Not too many people have been up there lately. Apparently only one person made it in 1986. I did not wish to go back the way I came so I more or less followed Route 7 and diagonalled back down toward the road. This was probably the thickest mess of undergrowth I have ever had to crawl through. Seven hours up to the summit and three hours down. I was exhausted but satisfied. The best time to do this climb is early in the season.
